1. Proposed Environmental General Obligation Bond Referendum

Deborah Drum, Department Director PBC Environmental Resources Management Patrick Rutter, Assistant County Administrator

Ms. Drum started her presentation by providing board members with an introduction and background about steps the County is taking in protecting the environment, land, and water resources. She went on to highlight the proposed projects in the county such as: Restore Lake Worth Lagoon, Loxahatchee River, Lake Okeechobee and the Intracoastal Waterway. Also, she mentioned that some of the proposed projects include the acquisition and restoration of environmentally sensitive lands and/or mitigation rights. Then, Ms. Drum provided membership with the financial summary of the \$150 million bond, ballot referendum, and ballot referendum draft language. In conclusion, education & outreach opportunities regarding this proposed environmental bond are done through advocacy groups.
