#### 7. Committee Reports

#### a. Environmental Committee:

#### 1. Re-Evaluation of Lake Okeechobee Operations Resolution Chair Council Member Patti Waller

Chair Council Member Patti Waller gave a recap of the committee's, March 15<sup>th</sup> meeting held in the League of Cities Office at the Governmental Center. First, Jeremy McBryan, Manager of the County Water Resources provided committee members with the issues the Water Resource Task Force faces such as the Loxahatchee River Restoration project, operational methods at Lake Okeechobee, and the water quality in Palm Beach County. Next, Meagan Houston of the PBC Resilience Office spoke to committee members about working on greenhouse gas emissions, renewable energy, storm water, and a resiliency manual. Then, Mayor Dan Comerford of Jupiter Inlet Colony, gave a legislative update, he spoke about fracking, home rule being under attack, wastewater penalties & residential recycling. In conclusion, there was a unanimous consensus to bring the Re-evaluation of Lake Okeechobee Resolution to the board for consideration. The resolution includes one addition that is the National Geodetic Vertical Datum (NGVD).

## c. PBC Days

### President Anne Gerwig

President Anne Gerwig provided membership with a brief recap of Palm Beach County Days held on March 5-6<sup>th</sup> in Tallahassee, FL.

### d. NLC Congressional City Conference:

- 1. Finance, Administration, & Intergovernmental Relations
  - Committee Vice Chair Leondrae Camel

Committee Vice Chair Leondrae Camel gave a brief report on the committee's discussions during the NLC Congressional City Conference held on March 10-13 in Washington D.C. Topics discussed were the 2018 tax cuts, municipal bonds, preparing municipalities for the 2020 Census, and fight for the state tax fairness. He mentions one of the highlights of the Conference were the infrastructural needs nationwide.

2. Community & Economic Development

## Vice Mayor Andy Amoroso

Vice Mayor Andy Amoroso gave an overview of his committee's discussions regarding broadband, opioid issues, home rule, etc. He also spent 2 hours with the U.S. Census Bureau in preparing for the upcoming census in 2020. The census will be online or by phone. In addition, he notifies membership that the U.S. Census Bureau is hiring with pay so let others know and they must be 18 years old.

#### 8. Legal Report

#### League Attorney Jennifer Ashton, Esq.

League Attorney Jennifer Ashton presents the Timbs vs Indiana case to the board membership involving the eighth amendment & contraband forfeiture. Timbs was arrested and his Land Rover SUV was seized during the arrest. The vehicle's forfeiture, the court determined, would be grossly disproportionate to the gravity of Timbs defense, and therefore unconstitutional under the Eighth Amendment's Excessive Fines Clause. The Supreme Court noted that the protection against punitive economic sanctions secured by the Clause was both fundamental to our scheme of ordered liberty and deeply rooted in this nation's history and tradition. While the U.S. Supreme Court did not expressly conclude that in this particular case the seizure was excessive, it did conclude that the Eighth Amendment has full application to the states, including the proscription against excessive fines. This case will change how the state extends civil forfeitures and used in the future by defendants charged with criminal violations. She advises municipalities that it is not wise to fight forfeiture cases.
