#### **MINUTES**

## 1. Call To Order, Roll Call, Welcomes, Introductions

President Lisa Tropepe called the meeting to order at 10:03 a.m. Kristen Puhalainen called the roll and a quorum was attained.

### 4. Scheduled Presentations

George Brown, Deputy Manager for the City of Boca Raton, explained that the FEC is planning to put cell towers on the FEC right-of-way. He would like a united approach to FEC, requiring them to adhere to the processes in each city in the corridor. He took questions.

Isaac Robinson, Jr. announced that he just received word that Past President Bill Moss had passed away. He left the meeting. Todd Wodraska moved to recess the meeting for 15 minutes. It resumed at 10:48.

## b. ITE Task Force

Task Force Chair Scott Maxwell reported that they met on the 23rd. Ethel Williams of Florida Power & Light gave a presentation on an upcoming seminar on utility incentives for local businesses. FPL would like participation from the municipalities. Information will be distributed as it becomes available.

They discussed law enforcement MSTU. Mr. Turnquest was unavailable to make a presentation, so the Task Force opted to take no action until a presentation can be made.

There was discussion on how to bring more value to the associate memberships.

They discussed creating an ITE award for presentation at the installation lunch. They are looking for nominees who have enacted a unique economic plan or process.

## c. Treasure Coast Regional Planning Council

Martha Webster gave a report on the Council.

President Tropepe reported that Carmine Priore's exit from office leaves a regular seat vacancy on the Council. Mr. Radcliffe is looking for a process for making replacements.

There was discussion.

By consensus, the regular seat will be opened to all alternates, with attendance records of those interested brought back to the Board in April.

#### d. Water Resource Task Force

Task Force Chair David Levy explained the purpose of the Task Force, and reported that they're currently working on a proposed rock pit called the C51 basin; he explained its relationship to the L8 basin. Also discussed was the numeric nutrient criteria. The next meeting is on April 19 and will include a tour of L8 rock basin.

## 7. Legal Report

Trela White reported that the Countywide Lobbyist Registration ordinance takes effect April 2nd. Municipalities that have their own ordinances may opt out.

The flood plain ordinances updates should be in the process of being passed.

In the case of the priority of code enforcement liens, oral argument before the Florida Supreme Court is set for April.

The Mandate has been issued in North Palm Beach's Foster's Pub case. It's going back to the trial court for an order. The Village prevailed in the case.

Red Light cameras: Broward County entered an order stating it's constitutional and upheld; Pasco County has issued an order stating that it's unconstitutional.

There was discussion on the lobbyist registration issue.

## 8. Executive Director's Report

Richard Radcliffe reported on the elected officials workshop scheduled to follow the April General Membership meeting.

He reported on the wellfield protection ordinance, which was discussed at Tuesday's County Commission meeting.

Manny Farach has been appointed as Chair of the ethics commission.

Congressman Ted Deutch is speaking to our membership on April 11th in Atlantis. It's \$20, please RSVP.

The Board directed the Transportation Committee to review the proposed revisions to the Vehicle for

Hire Ordinance. The moratorium will be extended, and they're going to allow more participation from the cities.
